ATTENTION: LIMITED VISITATION ALERT

To help protect our patients, providers, employees and community, the following visitation guidelines are in effect immediately:

Effective 05/03/2022

General Visitation Guidelines

Visitation Hours: [11:00am-2:00pm](#), [4:00pm-7:00pm](#)

- All visitors must **Enter** and **Exit** through **front lobby ONLY**
- Visitors must be **16 years of age or older**
- **All visitors will be screened for COVID-19 symptoms.** Any visitor who is deemed symptomatic or has a fever will be prohibited from visitation.
- If you've tested positive for COVID-19, please postpone visitation until 10 days have passed.
- **All visitors are required to show proof of COVID-19 vaccination or proof of a negative COVID-19 test prior to visiting a patient in our hospital.**
- For those visitors showing proof of a negative COVID-19 test result, specimen collection must have occurred within 2 days of the hospital visit for PCT tests, or within 1 day of the hospital visit for antigen tests. Home tests are not accepted.
- We strongly recommend that all visitors are vaccinated and have received a booster.
- Visitation of **COVID-19** or **COVID-19 PUI** patients will continue to be **restricted**, with exceptions made for end-of-life situations.
- All visitors must check in and out when they are leaving
- Visitors **must wear a mask** at all times while in the facility, and **comply with PPE** while in patient's room.
- Visitors may only be in the patient's room during the entire visitation. **Visitors should not walk around the hallways**, or the facility.

We thank you for cooperating with our visitation guidelines.



If you've tested positive for COVID-19, please postpone any patient visitation until 10 days have passed. If you are experiencing any COVID-19 symptoms, please **do not visit**.

We strongly recommend that all visitors are vaccinated and have received a booster.

If you are visiting for multiple consecutive days, proof of a negative COVID-19 test is only required every third day. This means that testing is only required on day 1, day 4, day 7, etc.

Patient Population	Visitors/Hours/Duration	Notes
Adult patients (no COVID-19) including semi-private rooms	1 healthy visitor at a time. Must be either fully vaccinated or have proof of a negative test result within 2 days for a PCR test or 1 day for an antigen test	
Adult patients – Near death (no COVID-19),	2 healthy visitors at a time	Imminent death determined by patient's Physician.
Pediatric patients (no COVID-19)	2 healthy parents/guardians at a time. Must be either fully vaccinated or have proof of a negative test result within 2 days for a PCR test or 1 day for an antigen test	
COVID-19 POSITIVE patients	No visitors at this time.	Exception for imminent death, determined by the patient's Physician
COVID-19 POSITIVE patients - Near death	1 healthy visitor allowed for a 2-hour visit	Imminent death determined by the patient's Physician

Emergency Department	Only 1 healthy visitor is allowed during the patient's stay in the Emergency Department. Must be either fully vaccinated or have proof of a negative test result within 2 days for a PCR test or 1 day for an antigen test	Visitors must: -Be flu/COVID symptom-free -Check in with ED -Wear a mask at all times -Stay in the patient's room / cubicle
